# Update from our Executive Director Lisa Lepine

The first four months of 2025 have provided extensive opportunities for advocacy on behalf of people with intellectual and developmental disabilities. Federal activity has the potential to change the lives of people served by The Arc for years to come. Changes in the workforce at the Social Security Administration, challenges to the Department of Education, reduction in staffing at the Centers for Disease Control, and discussion regarding the implementation of work requirements for Medicaid are all changes that directly impact those served by The Arc.

## April, Autism Acceptance

**Month**, brought autism directly into the spotlight when Secretary Robert F. Kennedy, Jr., Director of the Department of Health and Human Services (DHHS) uttered challenging statements regarding autism. The DHHS is the entity charged with managing Medicaid dollars for the federal government. Medicaid provides funding for support services for people with developmental disabilities accessing Community Mental Health services in Michigan. In May, it is expected that the House Energy and Commerce committee will present the actual budget reconciliation bill language for proposed

changes to Medicaid that include the possibility of establishing work requirements for individuals receiving benefits and caps on services for people with disabilities.

**The Arc of Macomb** is working diligently to advocate for our membership. Staff from The Arc have traveled to Washington, D.C. twice this year to meet with representatives and senators on both sides of the aisle to advocate zealously to maintain the programs, support and services that allow our community its independence. Every effort is being made to educate and advocate to maintain funding, retain laws and preserve regulations that protect and

promote the rights of people with disabilities. It is imperative that we continue to celebrate the value that all people bring to the world. Everyone is important. Everyone has a right to be part of the community. Everyone has value.

## The Arc of the United States

reminds us that "The Arc has done hard things before, and will do hard things in the future. The power of our collective voice – advocates, local chapters, state chapters, The Arc of the US – has changed the face of our country for the better, and we are not stopping now." The Arc of Macomb stands with The Arc US, The Arc Michigan and everyone battling to preserve and improve the lives of people with disabilities. We encourage our community to partner with and support us as we continue to rally and advocate!

# EDUCATION RIGHTS ARE UNDER THREAT

## Here's What You Should Know

Education is a civil right — especially for students with disabilities. But key protections like the **Individuals with Disabilities Education Act (IDEA)** and **Section 504 of the Rehabilitation Act** are currently under threat.

Proposals at the federal level would eliminate the **U.S. Department of Education** and move special education oversight to the **Department of Health and Human Services**. This would drastically weaken the system that ensures students with disabilities have access to individualized supports and inclusive classrooms.

### **WITHOUT THE DEPARTMENT OF EDUCATION:**

- Federal oversight and funding could disappear
- Students could lose the right to an Individualized Education Program (IEP)
- Families might lose due process protections
- States could set their own rules and reduce services



Even Section 504, which prohibits discrimination in schools, jobs, healthcare, and housing, is at risk. A lawsuit known as **Texas v. Becerra aims to eliminate 504 regulations entirely.**

At The Arc, we understand the vital role that early access to inclusive education plays in supporting individuals with intellectual and developmental disabilities (IDD). Services like IEPs and special education programs are not just beneficial—they are essential for helping individuals lead independent lives. These services provide a foundation that helps reduce the likelihood of vulnerability in the community and the risk of becoming involved in the criminal justice system.

If these protections were to disappear, the consequences for our community would be profound. Without access to the specialized education and support that IEPs provide, individuals with IDD would face even greater challenges in achieving independence, finding employment, and fully participating in society. The risks of increased vulnerability and criminal justice involvement would only grow, making it crucial to defend these vital protections for future generations.

# The Impact of Federal Medicaid Cuts

## A Critical Update for Michigan

Medicaid is essential for the well-being of millions of Michiganders, and proposed cuts to this program could have devastating effects. The Michigan Department of Health and Human Services (MDHHS) has issued Executive Directive 2025-3, outlining the severe consequences these cuts would have on healthcare access for Michigan residents, particularly those with disabilities.

### Federal Medicaid Cuts: Key Impacts

## 2.6 Million

Michiganders currently rely on Medicaid for health coverage, including 300,000 people with disabilities.

## 45% births

in Michigan are covered by Medicaid, which is critical for maternal and child health—especially in rural areas where healthcare access is already limited.

## 70% funding

of Medicaid in Michigan comes from the federal government. Reductions in federal support would result in cuts to services and strain Michigan's budget, jeopardizing coverage for vulnerable populations.

### A Vital Resource for People with Disabilities

Medicaid serves as a lifeline for people with disabilities in Michigan, covering over 300,000 individuals who depend on Medicaid for access to healthcare, long-term care, and other essential services. These cuts could result in the loss of care for individuals with disabilities, many of whom rely on Medicaid for critical support that allows them to live in the community.

### Economic and Healthcare Impact

- Medicaid supports Michigan's healthcare infrastructure, including hospitals, nursing homes, and community mental health centers. These institutions rely on Medicaid funding to provide services and support to people with disabilities.
- The proposed cuts could result in a \$2 billion loss in Medicaid funding for Michigan annually. This loss would disproportionately affect individuals with disabilities, who are more likely to rely on Medicaid-funded services.

### Protecting Medicaid for Michigan's Future

We must continue to advocate for the protection of Medicaid funding. The proposed federal cuts will threaten access to care for 1 in 4 Michiganders, including children, seniors, and individuals with disabilities. We encourage everyone to stay informed, voice their concerns, and advocate for policies that protect Medicaid and its vital services. ## Promoting Safety Through Special Needs Registries



The Arc proudly supports the growing network of Special Needs Registries, in collaboration with Crisis Intervention Team (CIT) Training, which help first responders assist individuals with disabilities safely and effectively during emergencies. Through SpArc, we encourage families to enroll in these voluntary programs, allowing caregivers to share vital information—such as medical conditions, communication preferences, and de-escalation strategies—with local law enforcement.

**Special Needs Registries are currently available through:**

Sterling Heights Police Department, Clinton Township Police Department, and Michigan State Police – VIP Program (Vulnerable Individual Program). Programs like these promote dignity, inclusion, and safety—values we advocate for every day.
